## Reeve Richard Chartrand

- Attended AMM Meeting
- Attended the Northwest Interlake Health Advisory Committee. There was some really great discussion and information provided:
  - o EMS Regional Manager attended;
  - o Ambulance in our region requires 8 paramedics to be operational and we currently have 4; we will be getting 4 more approximately in March;
  - Coming is a pilot project with Advanced Paramedics. This is like a doctor on wheels.
     They will tour the Interlake and alleviate some of the workload on the paramedics that would normally attend wellness calls etc.
  - o Discussions were held regarding adding ambulance bays at our station and at the Lundar station.
  - There is a program for reimbursement for FD attending lift assists. It is up to \$400 per call and is retroactive for 2024. CAO has been directed to contact the EMS coordinator to get information on process and procedures to complete these submissions.

Public Works/WTS - (presented by Reeve Chartrand)

- Christmas lights are coming down;
- Grader is being repaired;
- Regarding the WTS there was a question raised regarding sides being put on the trailer used for the garbage pick-up. It would allow more to be hauled at one time and reduce the number of trips to a specific area;
